## **Explanation of Responses:**

- 1. Currently vested restricted stock units (the "RSUs") and all RSUs vested as of December 31, 2020 will settle on February 15, 20201. Thereafter, any vested RSUs will settle on or following the vesting date, but no later than two and one-half months following the end of the year in which the vesting date applicable to a RSU occurs.
- 2. The RSUs granted to the reporting person are subject to a liquidity-based vesting requirement, which will be satisfied upon the IPO, and a service-based vesting requirement. Each RSU represents a contingent right to receive one share of Issuer's Class B Common Stock. Subject to the reporting person's continued service, 25% of the RSUs will vest on September 23, 2020, and 1/36th of the RSUs will vest monthly thereafter for a period of 3 years.
- 3. The RSUs granted to the reporting person are subject to a liquidity-based vesting requirement, which will be satisfied upon the IPO, and a service-based vesting requirement. Each RSU represents a contingent right to receive one share of Issuer's Class B Common Stock. Subject to the reporting person's continued service, 1/48th of the RSUs will vest monthly beginning on October 1, 2020 for a period of 4 years.
